<b>THE RANGE</b>	
<b>Name</b>	Century
<b>Description</b>	<p><b>Type:</b> Gallery Range</p> <p><b>Danger area:</b> Limited Danger Area (LDA)</p> <p><b>Distance:</b> 100 – 600yds</p> <p><b>Targets:</b></p> <ul style="list-style-type: none"> <li>• 128 target lanes divided into 10 butts</li> <li>• Butt 10: <ul style="list-style-type: none"> <li>○ 20 lanes for primary use of the 300m shed</li> <li>○ Lanes 1 – 8 are Kongsberg electronic targets</li> <li>○ Mcqueen Castles can be fitted on lanes 12, and 14/15.</li> </ul> </li> <li>• Butts 11 – 19: <ul style="list-style-type: none"> <li>○ 12 target lanes per butt</li> <li>○ Mcqueen Castles can be fitted on lanes 70, 72, 85, 87, 89, and 97.</li> <li>○ Butt 14 contains 12 Intarso electronic targets.</li> <li>○ Lanes 103 – 108 are Kongsberg electronic targets.</li> </ul> </li> </ul> <p><b>Additional notes:</b></p> <ul style="list-style-type: none"> <li>• Excluding specific events 100yds can only be shot on Butts 18 &amp; 19</li> </ul>
<b>FIREARMS AND AMMUNITION</b>	
<b>Permitted firearms and ammunition including ME &amp; MV</b>	<p><b>Type:</b> Rifles; gallery rifles, shotguns and pistols by special arrangement only</p> <ul style="list-style-type: none"> <li>• <b>Maximum Muzzle Velocity:</b> 1000 m/s (3280 ft/s)</li> <li>• <b>Maximum Muzzle Energy:</b> 4500 J (3319 ft/lb)</li> <li>• <b>HME Permitted:</b> 4500J – 7000J HME procedures apply</li> </ul>
<b>RANGE SAFETY LIMITATIONS</b>	
<b>Coordinating Instructions</b>	<ol style="list-style-type: none"> <li>1. Shooting on this range affects the following ranges: <ol style="list-style-type: none"> <li>a. Stickledown</li> <li>b. BSG (Cottesloe Heath)</li> </ol> </li> <li>2. <b>Access:</b> <ol style="list-style-type: none"> <li>a. To the butts is via the Markers walkway or Hobsons Way</li> <li>b. All firers must access and egress from the 600yd firing point of the appropriate Butt unless prior permission granted by the Range Safety Supervisor</li> </ol> </li> <li>3. Vehicles are not permitted on the range floor without prior permission from the range office.</li> <li>4. <b>Priority:</b> <ol style="list-style-type: none"> <li>a. If the NRA <b>DOES NOT</b> have priority, shooting is not permitted on Butts 10-13 inclusive.</li> <li>b. If the NRA <b>HAS</b> priority but the NCSC are operating, all areas forward of the 300yd point in Butts 10-13 are out of bounds.</li> </ol> </li> </ol>

	<p>5. If 300m shed is in use the following restrictions apply:</p> <ul style="list-style-type: none"><li>a. 300yd shooting is permitted from target 1</li><li>b. 400yds shooting is not permitted below (left of) Target 8</li><li>c. 500yds shooting is not permitted below (left of) Target 13</li><li>d. 600yds shooting is not permitted below (left of) Target 21</li></ul> <p>6. If only the LHS of the 300m shed is in use then the following restrictions apply:</p> <ul style="list-style-type: none"><li>a. 300yd shooting is permitted from target 1</li><li>b. 500yds shooting is not permitted below (left of) Target 9</li><li>c. 600yds shooting is not permitted below (left of) Target 17</li></ul> <p>7. 600yds shooting is not permitted on lane 108.</p> <p>8. No fire with movement is permitted in Butt 19.</p> <p>9. Courses of fire that involve movement (other than changing firing position e.g. from standing to kneeling) with a loaded firearm are forbidden except with prior authority of the CE.</p> <p>10. <b>Gates:</b></p> <ul style="list-style-type: none"><li>a. The 300m Shed gate must be closed and locked if shooting is from a distance greater than 300m in Butts 10, 11 or 12</li><li>b. The 500yd gate must be closed and locked if there is shooting from 600yds in Butts 11, 12 or 13.</li><li>c. The 300yd gate on the right hand side must be closed if shooting is from a distance greater than 300x in Butt 19.</li></ul>
<p><b>Firing Positions</b></p>	<p>11. All firing is to be conducted from the left of pegs.</p> <p>12. <b>Positions permitted:</b></p> <ul style="list-style-type: none"><li>a. Prone</li><li>b. Supine</li><li>c. Sitting</li><li>d. Kneeling</li><li>e. Standing</li><li>f. Benched</li><li>g. Lanes 85-108 at 400yds inclusive, prone/supine shooting is not permitted.</li></ul> <p>13. Permission to fire from any position other than prone/supine, or use a muzzle brake, must be notified in the booking request and granted by the Range Office in order to allow suitable target allocation on the range.</p>

<b>Targetry</b>	<p>13. Unless prior permission has been obtained from the CE only targets from the NRA approved set may be used.</p> <p>14. Targets are to be used in the frames or holders provided and are to be engaged only from the recognised firing points and /or appropriate shooting station or peg. Any deviation from this is to be notified, in writing, and approved by the Head of Range Services.</p> <p>15. Handheld targets are only to be exposed in or in front of target frames.</p> <p>16. Laterally moving targets are not permitted on Gallery ranges.</p>
