

CHEYLESMORE RANGE ORDERS FOR AFTER HOURS SHOOTING

Reference:

A. Bisley Ranges Regulations

1. These range orders complement Reference A and apply specifically to the use of Cheylesmore (Bay B) Range outside of normal shooting hours.

General

2. Cheylesmore is a No Danger Area (NDA) 25m range providing 3 Bays:

Bay A - provides 2 x banks of 5 electronic targets configured for ISSF rapid-fire pistol.

Bay B – provides 4 x banks of 5 turning targets.

Bay C – provides 2 Overhead Retrievable targets.

3. Due to its classification as an NDA Range, Cheylesmore (Bay B) Range may be used outside of normal shooting hours, subject to compliance with the regulations and conditions listed within Reference A and below.

Firearms

4. The firearms permitted to be used within Cheylesmore Range are restricted to a maximum MV of 655 m/s and a maximum ME of 2030 J.

5. Fullbore centre fire rifles, other than gallery rifles, are not permitted unless approved in advance by the CE.

6. Small-bore target rifles may be used for prone or 3-position shooting to NSRA or ISSF rules with prior permission from the Range Office.

7. Black Powder rifles and pistols may be used with the prior permission from the Range Office.

8. Shotguns may not be used within Cheylesmore Range.

Targets

9. Targets are to be mounted in the frames or holders provided and are only to be engaged from the recognised firing points. The following restrictions apply:

a. Unless prior permission has been obtained from the CE only targets from the NRA approved set may be used.

b. Hard targets are not permitted.

c. No laterally moving target may be used.

Supervision

10. All out of hours shooting is to be overseen by a nominated RO who is responsible for:

- a. Signing these range regulations on the attached certificate and in doing so accepting responsibility for all aspects of the activity.
- b. Compliance with all relevant Bisley rules and regulations, including these range orders.
- c. Ensuring that all personnel shooting are correctly qualified and entitled to do so.
- d. Ensuring that unqualified personnel are correctly supervised, a safety supervisor is required for each unqualified firer.
- e. The security of the range during and on completion of the event.
- f. Ensuring that no alcohol is taken in to the Range complex.
- g. Appointing a correctly qualified First Aider who is present during the event.
- h. Ensuring that a functioning means of contacting the emergency services is available at all times on the range when it is in use.
- i. Ensuring that enough people are present so that, if an incident occurs, control can be maintained and First Aid provided while sending a person with a vehicle to the main gate to guide emergency services.
- j. Collection and return of the keys and target remote controls from the Range Office.
- k. Signing on to the Range, in the Range Office, during the day preceding the event.
- l. Ensuring that firing ceases at 2100hrs at the latest.
- m. Reporting occurrences to the Range Office

Safety

- 11. Ear and Eye protection is mandatory.
- 12. All shooting is to be from a single firing line.
- 13. Cross lane firing is not permitted
- 14. In the event of an injury accident the RO is to seek assistance from the emergency services by dialing 999. In the event of any accident the RO is to inform the Head of Range Services (07980 457604). The RO is to report all other occurrences in accordance with Reference A to the Range Office at the earliest practicable opportunity
