## NRA RCO Certification—Military Conversion Application 2019

- You are currently a member of a Home Office Approved Club
- You are a Registered Firearms Dealer, the servant of an RFD, or the owner or employee of a company that has a contractual relationship with the NRA that involves firearms

Your NRA RCO card will be valid for 6 years from the date of conversion. You will need to include a **passport sized photograph** with your name written clearly on the back, **proof of military range course qualification** (e.g. copy of your course certificate or JPA record), and a **method of payment** with your application. During busy periods please allow up to 4 weeks for your renewal to be processed. **PLEASE PRINT CLEARLY.**
