

TRADE EXHIBITOR TERMS AND CONDITIONS

- 1. All trade exhibitors are to adhere to any specific requests made by the NRA with regards to set up and agree to man the stand between the official opening hours of the exhibition.
- 2. All trade exhibitors must wear trade show wristbands provided <u>at all times</u>. Anyone not showing a valid wristband will not be permitted to enter the exhibition area outside of normal trading hours.
- 3. On-site security will be provided by the NRA. Security guards will patrol the exhibition facilities outside of opening hours to protect the facility and control access of authorised persons only.
- 4. Trade exhibitors are wholly responsible for their own security arrangements for their licensable product at all times and are advised to fully insure their exhibits against such loss or damage, to include risk of fire. This responsibility extends to loss, damage or injury to property (including other exhibits) and persons, caused by themselves, their servants or agents.
- 5. RFD holders who are required to secure their stands on a 24 hour basis may do so as required, however all 'Traders Security Personnel' must be identifiable to NRA Security by displaying the valid wristband for access into trading area outside of trading hours. No accommodation facilities within the exhibition area are provided by the NRA.
- 6. RFD License holders will, at all times, strictly abide by the terms and conditions of such certificates and any other official published guidelines relevant to the possession and security of firearms and licensable product.
- 7. All firearms must be kept unloaded at all times. When carrying firearms from the exhibitor display stand and in public areas, they must be carried unloaded and in a slipcase, bag or case.
- 8. Trade exhibitors participating in the exhibition agree to indemnity the Organisers against all claims of whatsoever nature which may be made against the Organisers, arising out of, or in any way connected with, such Exhibitor's participation in the exhibition. This provision is specifically agreed by the Exhibitor to be fair and reasonable.
- 9. If a booking is received from any organisation, whose affairs are, for any reason, placed in the hands of a receiver, that application shall unless otherwise agreed in writing by the Organisers, automatically become null and void even if accepted.
- 10. Trade exhibitors must comply with all UK Statutory Requirements and Regulations whilst participating in the exhibition.
- 11. The Organisers reserve the right to refuse any entry whatsoever and also reserve the right to cancel any entry which may have been accepted without any reason being given, or decline at any stage to admit any proposed exhibit, or to order the removal of, or to remove any person or any exhibit from the exhibition. Whenever under this regulation an application for space is refused, or an allocation of space is cancelled by the Organisers, or an exhibit is refused admission or removed, the fees paid for such space may be at the discretion of the Organisers be refunded, and if refunded, shall be accepted by the Exhibitor or intending Exhibitor, in full satisfaction of all claims against the Organisers.



- 12. During the official opening hours of the show, and whenever the visiting public or NRA personnel are present in the exhibition halls, exhibitors displaying firearms, shotguns or air guns will, at all times, provide sufficient staff to man their exhibition stand so as to provide adequate security, control and observation of visitors to their stand.
- 13. During the official opening hours of the show, and whenever the visiting public are present in the exhibition halls, all firearms, shotguns or air guns will be securely displayed with an acceptable form of locking or security system to prevent unauthorised removal or unsupervised handling of such items.
- 14. Each trade exhibitor shall exhibit only materials and products of relevance to the sport of target shooting and related industry.
- 15. Trade exhibitors are not permitted to arrange their stand or to place a sign in such a manner as to obstruct the light, view or to inconvenience or disadvantageously affect the display of any other exhibitor. No form of intrusion into neighbouring stands will be permitted.
- 16. No person other than the registered trade exhibitor will be permitted to sell or display in any way on site. Sub-letting of stands is not permitted.
- 17. The National Rifle Association (NRA) will not be responsible for any accident, damage or loss however caused, which may occur to any exhibitor, articles or property brought onto the site. The NRA will not be responsible for any actions or expenses on account of, or in respect of any such damage or injury caused. All exhibitors must have full Third Party Insurance and if requested, will provide proof of current cover to the NRA. All exhibitors indemnify the NRA from any claims made in connection with exhibitor's staff, equipment, display, animals or vehicles.
- 18. The Organisers reserve the right to refuse entry to vehicles and/or persons to the exhibition and/or to divert visitors to car park areas.
- 19. Access to trade stands must be provided for the Organisers and official safety services for inspection purposes.
- 20. Each exhibitor is responsible for the removal of refuse from their stand and the site.
- 21. Visitors entering the exhibition do so entirely at their own risk. No liability will be accepted by the Organisers, their servants, agents, independent contractors or sponsors for any injury (including fatal injury), illness, damage or loss whatsoever directly or indirectly occasioned to person or property whether due to negligence or otherwise howsoever subject to the provisions of the Unfair Contract Terms Act 1977. Nor will the Organisers be obliged to refund any entrance monies should the exhibition not take place or be curtained or postponed for any reason.
- 22. Any behavior or practice in relation to the handling or display of firearms, which in the opinion of the Organisers is considered to be inappropriate or dangerous may result in the exhibitor being asked to close their stand, remove their exhibits and leave site.
- 23. UK legislation will apply to any matter regarding the handling or possession, use or display and sale of any firearms on site.
