| Description | <p>Type: Gallery Range Danger area: Full Danger Area (FDA) Distance: 800 – 1200yds Targets:</p> <ul style="list-style-type: none"> • 50 lanes at 800 – 1100yds • 25 lanes (21-33 and 39-50) at 1200yds • Buffalo target (lane 51) • Butt Zero range is located on the LHS of Stickledown <p>Additional notes:</p> <ul style="list-style-type: none"> • There is no firing facility forward of the 800yd firing point. • There is a road which cuts between firing points 30 and 31 for access in to BSG |

| Permitted firearms and ammunition including ME & MV | <p>Type: Rifles; gallery rifles, shotguns and pistols by special arrangement only</p> <ul style="list-style-type: none"> • Maximum Muzzle Velocity: 1000 m/s (3280 ft/s) • Maximum Muzzle Energy: 4500 J (3319 ft/lb) • HME Permitted: 4500J – 7000J HME procedures apply <p>Special Requirements:</p> <ul style="list-style-type: none"> • .338 for military use under MOD regulations on lanes 1 – 21 |
| RANGE SAFETY LIMITATIONS | |
| Coordinating Instructions | <ol style="list-style-type: none"> 1. Shooting on this range affects the following ranges: <ol style="list-style-type: none"> a. Butt Zero b. BSG when shooting 1200yds 2. Access: <ol style="list-style-type: none"> a. All movement forward of the 800yd point must be coordinated and controlled by the Range Office and is to be via the gate to the left of the 800yd firing point. b. Access requires the following ranges to have ceased fire: <ol style="list-style-type: none"> i. Stickledown ii. Butt Zero iii. Melville iv. BSRC v. Pirbright vi. Short Siberia 3. Vehicles are not permitted on the range floor without prior permission from the range office. 4. When the Ammunition Disposal range is in use, 800yds is not permitted. 5. 1200yd shooting is only permitted on targets 21 – 33 and 39 – |

| | <p>50 inclusive.</p> <ol style="list-style-type: none"> a. When shooting from lanes 46 - 50, a minimum of 11 target safety lanes must be applied. b. When shooting from lanes 39 - 45, a minimum of 10 target safety lanes is to be applied. c. When shooting from lanes 21 – 33, a minimum of 8 target safety lanes is to be applied. <p>6. 1200yds shooting is not permitted:</p> <ol style="list-style-type: none"> a. Lanes 27 – 33 and 39 – 50 unless the NRA has priority i.e. Cottesloe Heath is not in use. b. If Butt Zero is in use <p>7. Gates: When firing is conducted at 1200yds:</p> <ul style="list-style-type: none"> - Cottesloe Heath Barrier between 900x and 1000x CLOSED - 1200yd Firing Point Barrier CLOSED - 'STOP! Live Fire' board in the appropriate position on the range to the rear of the 1100yd FP. <p>If on lanes 21 – 26:</p> <ul style="list-style-type: none"> - William Evans Barrier CLOSED - Central Road Barrier @ 1100yds CLOSED - 1100yd Corner gate CLOSED <p>8. 1100yd shooting is not permitted on targets 43 – 50 if Cottesloe Heath is in operation.</p> <p>9. If Butt Zero is in use the following restrictions apply:</p> <ol style="list-style-type: none"> a. If the left hand bay is use, then 900 yard shooting is permitted from target 11 b. If the centre bay is in use, then 900 yard shooting is permitted from target 21. Safety boards must be in place along the flag line at target 16. c. If the right hand bay is in use for NRA events only, then 900 yard shooting is permitted from target 25 <p>10. If civil police are using Butt Zero, no shooting is permitted at 800yds on the range, or to the left of lane (below) 23 from 900yds.</p> <p>11. The following activities are not permitted on Stickledown Range when the civil police are using Butt Zero.</p> <ol style="list-style-type: none"> a. Guest Days b. Module 1 Probationary Training c. Any activity involving gallery rifles, shotguns or pistols d. Any activity involving automatic fire e. Any use of semi-automatic firearms other than by government personnel on duty f. Fire and movement g. Engagement of hard targets |
| <p>Firing positions</p> | <p>12. All firing is to be conducted from the left of pegs.</p> <p>13. Positions permitted:</p> <ol style="list-style-type: none"> a. Prone b. Supine c. Sitting d. Kneeling |

| | <p>e. Standing f. Benched</p> <p>14. Permission to fire from any position other than prone/supine, or use a muzzle brake, must be notified in the booking request and granted by the Range Office in order to allow suitable target allocation on the range.</p> |
| Targetry | <p>15. Unless prior permission has been obtained from the CE only targets from the NRA approved set may be used.</p> <p>16. Targets are to be used in the frames or holders provided and are to be engaged only from the recognised firing points and /or appropriate shooting station or peg. Any deviation from this is to be notified, in writing, and approved by the Head of Range Services.</p> <p>17. Laterally moving targets are not permitted on Gallery ranges</p> |
