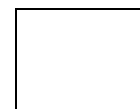

- If you are a FULL member of the NRA and would like to be assessed for an NRA Shooter Certification Card (SCC), this can be carried out on the day subject to prior agreement with the discipline representative. There is a fee of £5.00 for this, please inform us in advance if you require this facility.

Declaration

I make this entry subject to the NRA Rules of Shooting and Regulations.

I also certify that:

I am qualified to compete in accordance with the Regulations and hold a current Shooter Certification Card (SCC), which I will present at the meeting or I do not have an SCC and will need to be supervised throughout the event and will notify the RCO prior to shooting.

I am not a prohibited person within the meaning of Section 21 Firearms Act 1968 (as amended).

I have never had a Firearm or Shotgun Certificate refused or revoked.

I am over 14 years of age.

I hold a Firearm Certificate permitting me to use the firearms I shall use in this competition for target shooting or I am a full member of a Home Office Approved Club & will be shooting as a full member of that club and will use any firearm for which I do not hold an FAC only in accordance with the applicable exemptions to S1 Firearms Act 1968 as amended.
